#### September 26, 2023, SVAA Board Meeting Minutes

Meeting Called to Order: Betsy Baker, Chairman, called the meeting to order at 9:00am.

Roll Call: Debbie Meihls did the roll call.

**Approval of the Minutes:** Donna Ruby made a motion to approve the minutes, Jamie Dudley seconded the motion. All members were in favor.

**Chairman Report:** Chair Baker asked the board about revising the date for April 2024 and all approved the change from 4/23 to 4/30/24. Tom Clapsaddle resigned from the board due to relocation out of the area. Chair Baker congratulated Tom Clapsaddle long service to the SVAA Board. Chair Baker reminded the board that the budget was passed by Volusia County Council as presented and the CEO Review will stand with annual increase and merit as presented in the budget.

**Treasurer Report:** Donna Ruby presented the financials for May, June, July and August 2023, reporting that all expenses are normal within the planned budget and will file them for audit which will be taking place on October 31 – November 3<sup>rd</sup>. She noted that the CEO has already submitted many documents that were requested and when you get your in-kind forms in the mail, please make sure you reference any advertising cooperatives you did with NSBVB and/or in-kind donations.

Approval of the FY23/24 budget of \$7,023,240 was made by Volusia County on 8/15/23 and was reapproved by SVAA on 09/26/23 – Donna Ruby made the first motion and Rebecca Simmons Zerussen made a second motion, all board members were in favor.

A recess was called at 11:30-11:45am for a working lunch break, meeting called back to order at 11:46 am.

#### CEO Report:

Debbie Meihls recapped the CDT collections this fiscal year. There were 5 months that were down versus last year, but given we had 3 hotel properties and 4 condominiums shut down due to Hurricanes Ian and Nicole, we did very well year to date.

Meihls spoke of some film permits that have come through with one being larger and having a great potential for film tourism. Meihls mentioned Destination Florida coming to town on October 11-13, 2023, and taking approximately 90 room nights and renting restaurants for dinner and client networking. Meihls recapped the budget and marketing plan for fiscal year 2023/2024.
